The public may provide comment on any issue before the Fieldwork Communications Workgroup at the time the agenda item is discussed. If public comment is not specifically requested, members of the public should feel free to request an opportunity to comment.

Discussion and action may be taken on any item listed on the agenda.

- 3. Introductions by all Workgroup participants.
- 4. Public Comment Session for items not on the Agenda. *Please note: The Workgroup may not discuss or take action on any matter raised during this public comment session, except to decide whether to place the matter on the agenda of a future meeting. - 5. Group discussion and sharing of student placement challenges: *What does the Level II fieldwork crisis look like in California*? Defining and discussing the issue of too few fieldwork supervisors and facilities available for California's occupational therapy students to include in future report to the Board.
- 6. Discussion on and identification of objectives for fieldwork communication and outreach related to consumer safety and possible recommendation(s) to the Board.
- 7. Identify the Workgroup's next steps to determine need for another meeting.
- 8. Select future meeting date(s) if another meeting is necessary.

Public comments will be taken on agenda items at the time the item is heard. Discussion and action may be taken on any item listed on the agenda. Agenda items may be taken out of order for convenience, to accommodate speakers, or to maintain a quorum.

The Workgroup may discuss agenda items in any order on each day, unless noticed as "time certain." Agenda Items may be tabled or held over to a subsequent meeting and items noticed to be discussed may be moved up or taken out of order for convenience, to accommodate speakers, or to maintain a quorum. In the event a quorum of the Workgroup is unable to attend the meeting, or the Workgroup is unable to maintain a quorum once the meeting is called to order, the Board president may, at his or her discretion, allow the remaining members to discuss items from the agenda and to make recommendations to the full board at a future meeting.

Opportunity for public comment is provided for each open agenda item. The Workgroup Chairperson may, at her discretion, apportion available time among those who wish to provide comment.
