# CALIFORNIA BOARD OF OCCUPATIONAL THERAPY BOARD MEETING MINUTES May 24, 2007 Oakland, California

## N. Review and adoption of proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4141, Assessment of Administrative Fines

- ❖ Mary Evert moved to adopt the modified text to the proposed regulatory language to amend Title 16, Division 39, California Code of Regulations, Section 4141.
- Christine Wietlisbach seconded the motion.

## O. Review and adoption of proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4152.1 – Topical Medications

The Board discussed the modifications to the proposed language and the comments received by the American Occupational Therapy Association (AOTA). Ms. Martin commented that the term "protocol" should not be replaced in the language because the term is expressly used in the statute. Members discussed the other recommendation and determined that all of the issues were discussed and resolved at the last meeting. The suggestions made would cause redundancy in the language.

- Motion passed unanimously.

- P. Review and adoption of proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4154 Post Professional Education and Training, and Section 4155 Advanced Practice Certification.
  - Mary Evert moved to withdraw the proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4154 and Section 4155, re-notice the modified text, and schedule a public hearing the for next Board meeting.
  - Christine Wietlisbach seconded the motion.
  - Motion passed unanimously.
- Q. Review and approval of proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4161 Continuing Competency.

The Board was presented with two sets of proposed language to consider. Option 1 included only the language recommendation by the Practice Committee concerning applicants who have not practiced occupational therapy in the five years immediately proceeding submission of an application. Option 2 included the modification made in Option 1 in addition to language recommended by staff.

- Christine Wietlisbach moved to approve Option 1 as the proposed regulatory language to amend Title 16, Division 39, California Code of Regulations Section 4161.
- Mary Evert seconded the motion.
- Motion passed unanimously.
- Bobbi Jean Tanberg moved to schedule the language recommended by staff for the next Practice Committee meeting for discussion and recommendation.
- Mary Evert seconded the motion.
- Motion passed unanimously.
