After further discussion, the Committee decided that given the provision of the bill, including “an expected economic impact on California business exceeding \$50,000,000,” that it was unlikely to impact occupational therapists, occupational therapy assistants, or occupational therapy corporations, the Committee recommends the bill not be monitored by Board staff.
