The Committee may discuss agenda items in any order on each day, unless noticed as “time certain.” Agenda Items may be tabled or held over to a subsequent meeting and items noticed to be discussed may be moved up or taken out of order for convenience, to accommodate speakers, or to maintain a quorum.

In the event a quorum of the Committee is unable to attend the meeting, or the Committee is unable to maintain a quorum once the meeting is called to order, the Board president may, at his or her discretion, allow the remaining members to discuss items from the agenda and to make recommendations to the full board at a future meeting.

Opportunity for public comment is provided for each open agenda item. The Committee Chairperson may, at her discretion, apportion available time among those who wish to provide comment.
