  - f) SB 1423, Medi-Cal: critical access hospitals.

  - a) AB 47, Pelvic floor physical therapy coverage, and Board's position letter.
  - b) AB 381, Teacher credentialing: services credential with a specialization in health: occupational and physical therapists, and Board's position letter.
  - c) AB 796, Athletic trainers, the Board's position letter and Medical Board of California's position letter.
  - d) AB 1028, Reporting of crimes: mandated reporters.

- e) AB 1612, Clinics: licensure.
  - f) SB 802, Licensing board: disqualification from licensure: criminal conviction.
