#### 11:00 am - Committee Meeting

#### 1. Call to order, roll call, establishment of a quorum.

The meeting was called to order at 11:03 a.m., roll was called and a quorum was established.

#### 2. Chairperson opening remarks.

Board President/Committee Chair Richard Bookwalter noted that the agenda had been compiled by using keyword searches online to find relevant legislation, however, he welcomed any bills from the other committee members and members of the public that they found relevant.

#### 3. Introductions by all Committee Members.

Board Member/Committee Member Christine Wietlisbach introduced herself. She noted that this was her first Legislative and Regulatory Affairs Committee meeting as she had just been appointment to the committee.

Mr. Bookwalter introduced himself as the Board President/Committee Chair. He works for Kaiser Permanente in San Francisco with a focus on durable medical equipment and some nursing home rehabilitation oversight.

- 5. Discussion and development of possible recommendations to Board on the following *newly* introduced bills:
  - a) AB 2725, Teacher credentialing: occupational and physical therapists. The committee members recommended that the Board consider supporting AB 2725.

The committee agreed to make a recommendation to the Board to support AB 2725.

Samia Rafeedie, President-Elect Occupational Therapy Association of California (OTAC), confirmed that OTAC worked hard on AB 2725 and were grateful for the committee's support.

b) AB 2753, Rehabilitative and habilitative services: durable medical equipment and services.

The committee agreed to make a recommendation to the Board to watch AB 2753.

#### c) AB 3137, Department of Consumer Affairs.

The committee agreed to make a recommendation to the Board to watch AB 3137.

# a) AB 47, Pelvic floor physical therapy coverage, and Board's position letter.

The committee agreed to bring the letter of support to the May 2024 Board meeting to remind the Board of their previous position.
