Dear Assemblymembers:

The California Board of Occupational Therapy (Board) carefully reviewed and supports Assembly Bill (AB) 1009, as introduced on February 20, 2025. AB 1009 provides holding a valid license to practice occupational therapy or physical therapy and verification of meeting a basic skills requirement, along with three years of experience as a school-based occupational therapist (OT) or physical therapist (PT), may be used to satisfy requirements for a preliminary services credential with a specialization in administrative services.

AB 1009 represents a collaborative effort between the Occupational Therapy Association of California and the California Physical Therapy Association, with the support of multiple interested stakeholder groups, including the American Federation of State, County, and Municipal Employees; Association of California School Administrators; California Federation of Teachers; California Labor Federation; California School Employees Association; California State Council of Service Employees International Union; California Teachers Association; Los Angeles County Office of Education; and the Physical Therapy Board of California. The Board also supported AB 381 in 2023 and AB 2725 in 2024.

It's important to note that OTs and PTs complete rigorous education and training programs that lead to a master's and/or a doctoral degree. Therapists use their education and training to provide existing services to students without a credential and there is no apparent educational need or benefit to students to warrant the additional requirement of earning a teaching credential. AB 1009 would provide a pathway for California-licensed OTs or PTs interested in educational leadership opportunities to pursue an administrative credential. Earning the proposed service credential would grant OTs and PTs a greater voice on issues involving Occupational and Physical Therapy services in school systems and open the door for therapists to earn a higher salary. This may lead to greater retention and improved access to services for California student consumers of Occupational Therapy services.
